Ron began his employment with the County Public Works Department in 1978 as a Water Systems Worker I. He was promoted and progressed through the Water Systems Worker career series to Assistant Superintendent, and to his current position in 1997 as Water Systems Superintendent. Ron has demonstrated accomplished, considerate, sincere, fair-minded, and dedicated qualities, performing his assignments with methodical diligence toward completion of any task.

OTHER AGENCY INVOLVEMENT/IMPACT

Ron's primary area of service has been to the Zone 3 south county Lopez Water Project constituents, serving and providing State and Lopez treatment plant treated drinking water to the communities of Arroyo Grande, Pismo Beach, Grover Beach, Oceano, Avila Valley and Avila Beach areas. Ron also was responsible for maintaining and operating the San Luis Obispo Country Club wastewater collection and treatment system, as well as other water facilities in the County. Ron cultivated and maintained long term, cooperative, team-oriented working relationships with those he came in contact with in these communities, as well as with State regulatory agencies and various other County Departments.
