**RESOLUTION TO ESTABLISH 2015-16 SPECIAL TAX  
IN COUNTY SERVICE AREA NO. 21  
ORVILLE AVENUE IMPROVEMENT ZONE**

The following resolution is hereby offered and read:

Resolution to set special taxes for road improvements in County Service Area No. 21, Orville Avenue Improvement Zone.

**WHEREAS**, County Service Area No. 21, Orville Avenue Improvement Zone, has need to have special taxes levied therein for the 2015-16 fiscal year to cover the costs of providing debt service payment to the County of San Luis Obispo General Fund; and

**WHEREAS**, Section 25215.2 of the California Government Code provides for such special taxes to be levied upon each parcel of real property within said zone for such purposes, provided that an election is first held in said zone upon the question of whether such special tax should be levied; and

**WHEREAS**, Pursuant to California Government Code 50077, the voters of said zone, on March 4, 2008, 83% of those voting on the issue approved the levying of a special tax within said zone for the Fiscal Year 2011-12 and continuously thereafter for said purposes, providing said special tax does not exceed \$115.00 per front foot of improvement per parcel having a separate County Assessor’s Parcel Number and increasing not more than two (2) percent per year thereafter.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** the Board of Supervisors of San Luis Obispo, State of California, sitting as the Governing Board of County Service Area No. 21, Orville Avenue Improvement Zone, as follows:

1. That the recitals set forth hereinabove are true, correct and valid.
2. That the special tax rate for 2015-16 is hereby set within said Orville Avenue Improvement Zone at \$124.48 per front foot of improvement per parcel having a separate County Assessor’s Parcel Number.
3. That the special tax on the parcels of real property in County Service Area No. 21, Orville Avenue Improvement Zone, shall be and are hereby established, imposed and levied in the amounts set forth on Exhibit "A," which is hereby attached hereto and incorporated herein by reference as though here fully set forth.

4. That said special taxes shall be collected at the same time and in the same manner as the general taxes levied for County purposes.
