WHEREAS, Sid C. Stolper has been a proud member of the United Association of Journeymen and Apprentices of the Plumbing, Pipefitting and Sprinkler Fitting Industry of the United States and Canada (UA) since 1970 when he was initiated into Local 545; and

WHEREAS, in 1983 Sid was elected to serve as Business Manager for Local Union 403, a position he held for twelve years; and

WHEREAS, in 1994 Sid was elected to serve as Business Manager of the Southern California Pipe Trades District Council 16, where he continues to serve the Council’s affiliated Locals and more than 15,000 members of the UA; and

WHEREAS, from 1979 to the present, Sid has faithfully served the UA membership in various capacities, including, but not limited to, Vice President of Local Union 403, Trustee of the Southern California Pipe Trades Trust Funds, Secretary of the Joint Arbitration Board of the Southern California Pipe Trades, Vice President and President of the California Pipe Trades Council, Vice President of the United Association 5th District (representing the 11 western states of the United States) and General Executive Board member of the UA; and

WHEREAS, in addition to Sid’s union responsibilities, over the years he has volunteered in many civic activities, to include, the Economic Advisory Committee to the Board of Supervisors of San Luis Obispo County, the Narcotic Addict Evaluation Authority of California, and Commissioner and Vice President of the Los Angeles Department of Water and Power; and

WHEREAS, in 2013 Sid was honored by the International Association of Plumbing and Mechanical Officials and received the George Kauffman Lifetime Achievement Award.
