The Slo animal shelter is in desperate need of an update. Since the shelter was built in the

70's the population of slo county was 1/2 of what it is now. the animal population has also doubled or tripled. Animals are turned into the shelter for many reasons, either they get lost

and end up at the shelter. The family has to move or the owners die and the animals come to

the shelter. many, many reasons for an increased census. When the shelter gets too crowded

and runs out of space as it does often during the year, there is no room for new animals

to go. that means that healthy, adoptable animals must be euthanized to make space. We need

to be able to accommodate all county animals that come to the shelter through no fault of

their own, we need a larger, updated, modern shelter. I hope that when budget consideration

comes around in April that our only county animal shelter will receive merit. The shelter

has always seemed to be the "stepchild" and gets the leftovers if there are any. The animals deserve to be humanly treated, they deserve a chance to hope for a new home and I think we as a county need to provide the shelter and care for them until they can be safely returned to their owner or find them a new home. Please consider at least looking into or finding funding for our county's homeless animals. Dear San Luis Obispo County Board of Supervisors,

On April 7<sup>th</sup>, 2015, you will be presented with a staff report from San Luis Obispo County Health Agency Director Jeff Hamm. This report will update you on the County's Animal Shelter Facility and provide options to consider regarding site improvements and/or the construction of a new facility.

Although I also recognize the need for improvements at the County Animal Shelter Facility, the City of Paso Robles must take into consideration all public safety priorities and ensure basic core services are being provided to our community. The cost to fund our existing contract, and that of the proposals going before you, are disproportionate to other public safety priorities such as basic patrol services, gang / narcotics enforcement and traffic safety.

The City of Paso Robles currently pays approx. \$300,000 a year to contract with the County's Animal Services Division; the proposed improvements or new facility will drive that cost much higher. Figures provided by Director Hamm suggest the new annual cost to the City of Paso Robles with the option of facility improvements will be approx. \$337,500. Additionally, the suggested new annual cost to our City with a newly constructed facility will range between approx. \$401,000 and \$446,000.

The anticipated cost increases, especially that of a new facility, may price the City of Paso Robles out of the County's Animal Services Contract.

I urge you to thoroughly review the options before you on April 7<sup>th</sup> and consider the impacts to the incorporated communities that you partner with. If you determine something must be done then please move forward with less expensive options.
