**RESOLUTION RECOGNIZING FRENCH HOSPITAL MEDICAL CENTER FOR**  
**RECEIVING THE TRUVEN HEALTH ANALYTICS “TOP 100 HOSPITAL IN THE**

**WHEREAS**, French Hospital has been proudly providing leading edge medical treatment to our local community since 1946 when specialist Dr. Edison French purchased the San Luis Sanitarium on Marsh Street and renamed it French Hospital; and

**WHEREAS**, In 1972, French Hospital relocated and opened the doors to a larger French Hospital located on Johnson Avenue in San Luis Obispo; and

**WHEREAS**, in 2004, French Hospital Medical Center was acquired by Dignity Health, a system of 42 hospitals and medical centers in California, Arizona and Nevada; and

**WHEREAS**, until the present, French Hospital Medical Center is recognized as one of the top-rated cardiac hospitals in the country with a proven record of excellence in cardiac care and is recognized as one of the Nation’s Top 100 Cardiac Hospitals in 2008, and as a Top 50 Cardiac Hospital in 2010, 2011, and 2013 by Truven Health Analytics; and

**WHEREAS**, in addition to French Hospital Medical Center’s cardiac capabilities, French Hospital has ranked among the top 10% in the Nation for joint replacement for six years in a row and is the recipient of the Healthgrades Joint Replacement Excellence Award; and

**WHEREAS**, in 2015, French Hospital Medical Center has received the Patient Safety Excellence Award from Healthgrades; and

**WHEREAS**, in 2015, and for a second time, French Hospital Medical Center has been named as a Top 100 Hospital in the Nation by Truven Health Analytics.
