## **DISCUSSION**

The American Probation and Parole Association designates one week each year as Probation Services Week. During Probation Services Week, people across America will join together to honor and celebrate the work done by Probation employees.

The role of the Probation Department is to keep the community safe, reduce recidivism among those placed under Probation's supervision and to return restitution due to victims. In order to accomplish this, the Department has adopted the evidence-informed *Risk, Needs and Responsivity* model.

The Probation Department provides a wide spectrum to the County's justice system. The services exist along a continuum of care that ranges from early intervention gang resistance programs in the elementary schools to working side by side with law enforcement on gang and narcotic task forces and all the while providing these services with dignity, integrity, empathy, professionalism and pride.

Probation Services Week has been celebrated annually by the San Luis Obispo County Probation Department since 2006.
