**RESOLUTION CONFIRMING AND ORDERING AMENDED
ASSESSMENTS FOR SAN LUIS OBISPO COUNTY
SAN MIGUEL/SAN LAWRENCE TERRACE ASSESSMENT DISTRICT,
AND NORTH MESA ASSESSMENT DISTRICT**

The following resolution is now offered and read:

WHEREAS, on June 2, 2015, this Board duly adopted a Resolution directing the County Surveyor to prepare assessment apportionments for said assessment districts, and pursuant thereto said County Surveyor duly prepared the same and filed the same with the Clerk of this Board on June 2, 2015; and

WHEREAS, on January 19, 1999, by Resolution No. 99-27, the issuance of bonds under the Improvement Act of 1915 was approved by the San Luis Obispo County Board of Supervisors for the “North Mesa assessment district”; and

WHEREAS, on May 3, 1994, by Resolution No. 94-190, the issuance of Series A bonds under the Improvement Act of 1915 was approved by the San Luis Obispo County Board of Supervisors for the “San Miguel/ San Lawrence assessment district”; and

WHEREAS, on May 3, 1994, by Resolution No. 94-191, the issuance of Series B bonds under the Improvement Act of 1915 was approved by the San Luis Obispo County Board of Supervisors for the “San Miguel/ San Lawrence assessment district”; and

WHEREAS, due notice was given of a time and a place for public hearing concerning the amended assessments, and this is the time and place for said hearing; and

WHEREAS, opportunity was given at such hearing for persons to make any objections to and/or protest against amended assessments; and

WHEREAS, this action to amend assessments is a condition of property development and is not an action to establish a new or increased assessment; and

WHEREAS, it is in the public interest that said amended assessments confirmed and/or modified as set forth hereinafter.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, as follows:

1. That the recitals set forth hereinabove are true, correct and valid.
2. That for San Miguel Assessment District, and North Mesa Assessment District the amended assessments, as set forth in the documents attached hereto marked Exhibit "A," which is hereby incorporated herein by reference as though here fully set forth, be and hereby are confirmed and ordered.
3. Direct the Clerk to file the confirmed amended assessments with the County Auditor, who shall annually thereafter enter upon the assessment roll the installments becoming due to each component part of the original parcel opposite a description of the respective parcel so assessed.
4. That the costs and fees for each parcel for the County to prepare the report, maps or plats, necessary amended assessment and notice, as previously fixed by the Board, shall be entered upon the assessment roll and collected along with the property tax bill.
5. That the Director of Public Works shall deposit all such fees and costs in the General Fund in the County Treasury.
6. That the County Clerk shall file the amended maps or plats with the San Luis Obispo County Recorder, who shall cross index such amended maps or plats to the original assessment diagrams which they amend.
