SUBJECT: Submittal of a resolution providing for a service charge credit/rebate for parkway facilities services in County Service Area No.1A (Galaxy Park, Tract 1898, Nipomo) Budget Unit 2500001000. District 4.

RECOMMENDATION

It is recommended that the Board adopt the attached resolution which would approve a service charge credit/rebate for FY 2015-16 in CSA 1A, Tract 1898 of \$20.00 per APN.

DISCUSSION

On April 12, 1994, Ordinance #2670 was approved which established a \$7 per month (\$84 per year) service charge for Parkway Facilities services for each Assessor Parcel Number (APN) in Tract 1898 within County Service Area 1A in Nipomo. Parkway Facility Service provides for landscape maintenance within the public right of ways.

When preparing the budget for Fiscal Year 2015-16 it was determined that the full service charge would not be needed to fund the 2015-16 budget, and sufficient reserves had been established so that it would be possible to provide a Credit/Rebate for Fiscal Year 2015-16 of \$20 per APN. The net service charge of \$64 per APN was included in the budget that was approved by the Board of Supervisors for 2015-16.

This Credit/Rebate will only be in effect 2015-16. The possibility of future Credit/ Rebates will be evaluated during the annual budget process.

OTHER AGENCY INVOLVEMENT/IMPACT

The Auditor/Controller/Treasurer/Tax Collector collects the charges on the property tax bills. County Counsel has approved the attached resolution as to legal form and effect.

FINANCIAL CONSIDERATIONS

The 2015-16 budget includes \$6,228 in net service charge revenues, which is calculated at \$64 per APN. Existing reserves of \$33,600 are sufficient to cover any budget shortfall that might occur.

RESULTS

Approval of the recommended action will ensure that the property owners pay no more than necessary for Parkway Facilities Services in their neighborhood, thus increasing their quality of life.
