WHEREAS, Eric Burt continues to demonstrate excellence and dedication in his current assignment, and his professionalism and clinical skills benefit many children and their families in our County; and

WHEREAS, Eric Burt continues through all his years to be recognized for going above and beyond for the clients he served.
