Name – Arroyo Grande – retired SLO County Park Ranger.

I urge you to follow the recommendation of your Department of Planning and Building staff to deny this proposal.

I share the many local, regional, and statewide concerns regarding this project. However, my most serious concern is that – projects such as this – are clearly a threat to our shared climate.

As the applicant states, “oil will come”, and I get that – but where the oil comes from is important to consider.

The two crudes listed in the EIR that could be delivered by rail are both Canadian tar sand dilbits. The extraction, transportation, and refinement of tar sands increase climate change. That is not an opinion – that is a fact!

Tar sands oil is not only one of the world’s dirtiest – it is also much more difficult to clean up after a spill. A 2015 “National Academy of Sciences” report concludes that oil spill response efforts are not adequate when it comes to spills involving crude from Canadian tar sands. This crude degrades into a substance so chemically and physically different than conventional oil, that it defies standard oil spill response plans.

The applicant states, this project is even more urgent for them, as they need this, because of the All-American pipeline spill in S.B. County resulting in environmental disaster on our coastline. If anything, we should learn from this pipeline spill – we, the people, don’t need this project because of the Refugio spill!

You are hearing two differing voices on this proposal. One voice, your professional county planners. The other voice Phillips 66.

Phillips 66 - is a spin-off from Conoco Phillips. Conoco Phillips, through the Western States Petroleum Association, supports attacks on climate and clean energy solutions in CA, Oregon, and Washington. From the Union of Concerned Scientists report in 2015,

In Conclusion:

We cannot afford to allow the oil and gas industry to determine our future. Phillips 66 does not need our help with their bottom line, and your job is not to enhance the economic vitality of Phillips 66. Please, do not let them worsen climate change, and put our air, our land, and our water at risk.





Good morning (afternoon). I'm James V. Murray, a retired copy editor from San Jose. Along with quite a few of my neighbors, I got up at 5 this morning to be here.

In my city alone, more than 195,000 people live in the blast zone. That's the one-mile area that must be evacuated if an oil-train goes off the tracks. My wife and I live just a mile and a half from those tracks.

The Phillips 66 proposal would have 20,800 tanker cars full of tar-sands crude rattling up and down those tracks every year.

I think this madness, and here are four reasons why:

1) There is a strong possibility of catastrophic explosions from derailments. There have been 31 train crashes involving crude or ethanol since 2013. About two-thirds of these caused spills, fires or explosions. Firefighters in San Jose have told me that they can't put out a tar-sands oil fire. All they can do is evacuate survivors and let the fire burn itself out.

2) Besides belching diesel fumes, 550 trains a year would leak sulphur dioxide, benzene, toluene and xylene.

3) If a derailment occurs, <sup>30,000</sup>~~3,000~~ gallons of crude oil would enter our water supply. (That's in addition to the toxins that are added to liquify the crude).

4) Removing oil from tar sands is accelerating climate change. The seas are rising. The weather is becoming bizarre.

Phillips 66's scheme is a recipe for disaster, and this is our last chance to stop it.






