RESOLUTION COMMENDING ERIC N. WIER

WHEREAS, Eric has been an instrumental team member in many small and large-scale projects, including bridge replacements, water system upgrades, wastewater projects, and the recently completed Nacimiento Water Project; and

WHEREAS, Eric continues to demonstrate excellence and dedication in his current assignments, and genuinely seeks to serve San Luis Obispo County and its residents and natural communities; and

WHEREAS, Eric has demonstrated his balanced approach to life by incorporating water-polo, volunteering with the local Audubon Society, birding, traveling, and camping with his family and friends into his leisure time.
