**RESOLUTION APPROVING CONTRACT PURSUANT
TO THE CALIFORNIA LAND CONSERVATION ACT OF 1965**

The following resolution is hereby offered and read:

WHEREAS, Government Code Section 51240 provides that the County may enter into contracts for the purpose of preserving agricultural land within an agricultural preserve; and

WHEREAS, Government Code Section 51243 requires that the County limit such land to those uses which are compatible with agricultural uses; and

WHEREAS, such a Land Conservation Contract (the "Contract") has been presented to the Board of Supervisors by PETER G. CLARK, TRUSTEE OF THE PETER G. CLARK REVOCABLE TRUST, DATED SEPTEMBER 27, 2001, AND PAUL E. CLARK, TRUSTEE OF THE PAUL E. CLARK REVOCABLE TRUST DATED JUNE 22, 1999, owner of the land described therein, which land is within an agricultural preserve previously established by the Board of Supervisors; and

WHEREAS, the Contract presented is in the form previously approved by the Board of Supervisors; and

WHEREAS, the applicant for the Contract has presented to the County all necessary supporting documents as required by Rules of Procedure adopted by the Board of Supervisors; and

WHEREAS, all owners of the property and all trust deed beneficiaries and mortgagees of the property have properly executed said Contract and their signatures thereto have been notarized; and

WHEREAS, the Board of Supervisors finds it is in the public interest to approve execution of the above Contract; and

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, as follows:

1. The Land Conservation Contract submitted by PETER G. CLARK, TRUSTEE OF THE PETER G. CLARK REVOCABLE TRUST, DATED SEPTEMBER 27, 2001, AND PAUL E. CLARK, TRUSTEE OF THE PAUL E. CLARK REVOCABLE TRUST DATED JUNE 22, 1999, on file with the Clerk of the Board of Supervisors is hereby approved by the County of San Luis Obispo and the Chairperson of the Board of Supervisors is authorized and directed to execute said Contract on behalf of the County of San Luis Obispo.
2. The Clerk of the Board of Supervisors is authorized and directed to record the above Contract in the Office of the County Recorder of the County of San Luis Obispo.
3. The Contract presented supersedes and replaces the existing contract entered into on December 10, 2013, approved by Resolution No. 2013-305 and recorded on December 19, 2013 as Document No. 2013-068981.
