RESOLUTION COMMENDING MICHAEL LeBRUN FOR HIS SERVICE TO THE RESIDENTS OF NIPOMO AS GENERAL MANAGER OF THE NIPOMO COMMUNITY SERVICES DISTRICT

The following resolution is hereby offered and read:

WHEREAS, Michael S. LeBrun has served as the General Manager of the Nipomo Community Services District (NCSD) for a combined total of over 7 years; and

WHEREAS, Under Michaels leadership NCSD was the first special district in San Luis Obispo County to receive the Government Finance Officers Association Award for Financial Reporting Achievement; and

WHEREAS, Under Michaels leadership NCSD received the Special District Leadership Foundation Transparency Certificate of Excellence in 2013, 2014 and 2015; and

WHEREAS, With Michaels management NCSD was able to maintain 100% compliance with regulator monitoring and reporting requirements and received no regulatory violation notices; and

WHEREAS, With Michaels management NCSD maintained an active safety program with zero loss-time accidents or injuries and no workers compensation claims in recent years; and

WHEREAS, Michael led District Water Conservation efforts to reduce overall District water use by 30%; and

WHEREAS, Michael led the completion of the Southland Wastewater Facility Upgrade Project; and

WHEREAS, Michael led the completion of phase one of the 17 million dollar supplemental water project which brings 645 acre feet of water from the city of Santa Maria to the Nipomo Mesa, this reduced the District's groundwater pumping an average of 45% each month; and

WHEREAS, Michael initiated a grant agreement with the Nipomo Chamber of Commerce for "Keeping Nipomo Clean" solid waste removal program; and

WHEREAS, Michael maintained top quality working relationships with County and City officials and District employees; and

WHEREAS, Michael accomplished the mission of the Nipomo Community Services District to provide customers with reliable, quality and cost effective services.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, by the Board of Supervisors of San Luis Obispo County, State of California does hereby appreciate and recognize Michael LeBrun for his years of service to the community of Nipomo as the General manager of the Nipomo Community Services District and we wish him health and happiness in the future.
