RESOLUTION OF THE BOARD OF SUPERVISORS
OF SAN LUIS OBISPO COUNTY
RECOGNIZING MIKE DUTRA FOR HIS
SEVENTEEN YEARS OF SERVICE TO THE COUNTY

WHEREAS, on May 14, 2016, Mike Dutra will be retiring after seventeen years of service to the County of San Luis Obispo and twenty-six years to the community corrections profession; and

WHEREAS, Mike began his career in community corrections as a Senior Group Counselor for the Santa Clara County Probation Department in January of 1990 and was hired by the San Luis Obispo County Probation Department as Deputy Probation Officer in September of 1998; and

WHEREAS, Mike distinguished himself as a field officer and member of the County Gang Task Force and received letters of recognition from law enforcement for his assistance and participation in criminal investigations and enforcement operations; and

WHEREAS, In November of 2004, Mike was promoted to the position of Supervising Deputy Probation Officer and demonstrated effective leadership skills including involvement in the establishment of the San Luis Obispo County Probation Peace Officers' Association; and

WHEREAS, Mike distinguished himself as a supervisor by developing solid relationships built on trust and respect with his subordinates that brought the best out of those employees he supervised; and

WHEREAS, In October of 2008, Mike was promoted to the position of Probation Division Manager and under his leadership and guidance enhanced the quality of the Probation Department's firearms training program so that it is now considered a model for Probation Departments across the state; and

WHEREAS, In July 2010, Mike was promoted to the position of Chief Deputy and has worked to significantly reduce and divert the number of youth from the juvenile justice system and to enhancing the quality of officer safety training and equipment for Deputy Probation Officers.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of San Luis Obispo, State of California, hereby recognizes and celebrates Chief Deputy Probation Officer Mike Dutra's seventeen years of dedicated service to the citizens of San Luis Obispo County.


