SUBJECT: Request to approve a resolution from the Cayucos Fire Protection District, requesting consolidation of the district election with the June 7, 2016, Presidential Primary Election. All Districts.

## **RECOMMENDATION**

It is recommended that the Board approve a request from the Cayucos Fire Protection District requesting consolidation of its district election with the June 7, 2016, Consolidated Presidential Primary Election.

## **DISCUSSION**

Whenever an election is called by a district for the submission of any question to be held on the same day as a statewide election, the district shall file a resolution of its governing board requesting consolidation of the election with the statewide election. By consolidating, the measure will be on the same ballot as the statewide offices and measures. The resolution to consolidate must be filed with the Board of Supervisors and the County Elections Official at least 88 days prior to the election.

The Cayucos Fire Protection District has filed the required resolution and is requesting consolidation with the June 7, 2016, Presidential Primary election.

## **OTHER AGENCY INVOLVEMENT/IMPACT**

The Cayucos Fire Protection District has filed the required resolution, as required by law.

## **FINANCIAL CONSIDERATIONS**

The current estimate of the total cost of the election is \$500,000. The Cayucos Fire Protection District will be billed for their pro-rata share of the costs of conducting the election. In the resolution requesting consolidation, the District has agreed to reimburse the County for these costs.

## **RESULTS**

To comply with the Election Code requiring Board approval of the consolidation of district and city elections with the statewide general election.
