RESOLUTION APPROVING AMENDMENTS TO THE SAN LUIS OBISPO COUNTY
EMPLOYEES RETIREMENT PLAN APPENDICES FOR EMPLOYEES IN THE SAN LUIS
OBISPO COUNTY COURTS PER APPLICABLE INSTRUCTIONS OF AUTHORIZED
INDIVIDUALS REPRESENTING SAID AGENCY

The following resolution is hereby offered and read:

WHEREAS, amendments to the San Luis Obispo County Employees Retirement Plan include an amendment to Appendix A – Miscellaneous Members Contribution Rates Tier 1, and Appendix A – Miscellaneous Members Contribution Rates Tier 3-AB340, attached hereto; and

WHEREAS, it is in the best interest of the County of San Luis Obispo that the Board of Supervisors approve these revisions to the San Luis Obispo County Employees Retirement Plan, attached hereto.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California as follows:

1. That the recitals set forth hereinabove are true, correct, valid and incorporated herein; and
2. That effective the pay period that includes June 1, 2016, the employer pickup of employee contributions for employees of the San Luis Obispo County Superior Court shall be 0.00%.
3. That retroactively effective to the pay period that included January 1, 2016, the pension contribution rate for employees in San Luis Obispo County Superior Court Bargaining Unit 17 shall be corrected to increase by 0.49% resulting from the Pension Trust's 2014 actuarial study (report dated January 1, 2015). The Employer's appropriation rate shall also be corrected to increase by 0.49%; and
4. That retroactively effective the pay period that included January 1, 2016, the bargaining unit title for San Luis Obispo County Superior Court Bargaining Unit 25 be changed

from "Commissioners & Attorneys" to "Commissioners", and the bargaining unit title for San Luis Obispo County Superior Court Bargaining Unit 24 be changed from "General Management" to "General Management & Attorneys".

- 5. That the San Luis Obispo County Employees Retirement Plan is hereby amended to include the revisions to Appendix A – Miscellaneous Members Contribution Rates Tier 1, and Appendix A – Miscellaneous Members Contribution Rates Tier 3-AB340; and
- 6. That Appendix A – Miscellaneous Members Contribution Rates Tier 1, and Appendix A – Miscellaneous Members Contribution Rates Tier 3-AB340 to the San Luis Obispo County Employees Retirement Plan be revised; and


