1. On September 5, 2000, your Board awarded a five-year consultant services contract to The Gordian Group to provide program software and support services to implement the Job Order Contract construction services procurement program.
2. On November 21, 2000, your Board authorized a public bid of Job Order Contract, PJOC1. On January 9, 2001, your Board awarded Job Order Contract, PJOC1 to THI Group, Inc. with a total composite bid factor of 1.1845.
3. On November 20, 2001, your Board authorized a public bid of Job Order Contract, PJOC2. On January 8, 2002, your Board awarded Job Order Contract, PJOC2 to John Madonna Construction Company with a total composite bid factor of 1.0600.
4. On November 5, 2002, your Board authorized a public bid of Job Order Contract, PJOC3. On December 17, 2002, your Board awarded Job Order Contract, PJOC3 to John Madonna Construction Company with a total composite bid factor of 1.0523.
5. On November 25, 2003, your Board authorized a public bid of Job Order Contract, PJOC4. On January 27, 2004, your Board awarded Job Order Contract, PJOC4 to R. Simons Co., Inc. with a total composite bid factor of 1.0656.
6. On November 9, 2004, your Board authorized a public bid of Job Order Contract, PJOC5. Your Board also approved Board Resolution No. 2004-352 to establish the Job Order Contract program as an approved procurement method to secure construction services for maintenance and renovation projects. On January 4, 2005, your Board awarded Job Order Contract, PJOC5 to R. Simons Co., Inc. with a total composite bid factor of 1.0240.
7. On August 23, 2005, your Board granted a waiver of a Request For Proposal for Job Order Contract consultant services. In addition, your Board approved an amendment to extend an existing five-year, Job Order Contract consultant services agreement between the County and The Gordian Group for an additional five years.
8. On November 8, 2005, your Board authorized a public bid of Job Order Contract, PJOC6. On January 10, 2006, your Board awarded Job Order Contract, PJOC6 to T. Simons Co., Inc. with a total composite bid factor of 1.0100.
9. On September 26, 2006, your Board authorized a public bid of Job Order Contract, PJOC7. On November 14, 2006, your Board awarded Job Order Contract, PJOC7 to T. Simons Co., Inc. with a total composite bid factor of 1.0100.
10. On December 11, 2007, your Board authorized a public bid of Job Order Contract, PJOC8. On January 29, 2008, your Board awarded Job Order Contract, PJOC8 to T. Simons Co., Inc. with a total composite bid factor of 1.0025.
11. On November 25, 2008, your Board authorized a public bid of Job Order Contract, PJOC9. On February 24, 2009, your Board awarded Job Order Contract, PJOC9 to Sea Pac Engineering, Inc. with a total composite bid factor of 0.9590.

12. On January 5, 2010, your Board authorized a public bid of Job Order Contract, PJOC10. On March 16, 2010, Job Order Contract, PJOC10 was awarded to Sea Pac Engineering, Inc. with a total composite bid factor of 0.7890.
13. On May 18, 2010, Job Order Contract, PJOC10-2 was awarded to Staples Construction Co. Inc., with a total composite bid factor of 0.8678.
14. On September 14, 2010, your Board approved an amendment to extend the current Job Order Contract consultant services contract with The Gordian Group from September 4, 2010 to May 24, 2011. This housekeeping effort will synchronize the expiration dates of the current Job Order Contract construction services contract and the Job Order Contract consultant services agreement of The Gordian Group.
15. On April 5, 2011, your Board authorized a public bid of Job Order Contract, PJOC11. On June 7, 2011, Job Order Contract, PJOC11 was awarded to Sea Pac Engineering, Inc. with a total composite bid factor of 0.7800.
16. On May 24, 2011, your Board approved a new five-year consultant services contract to The Gordian Group to provide, administer, and support a Job Order Contract construction procurement program.
17. On April 10, 2012, your Board authorized a public bid of Job Order Contract, PJOC12. On August 7, 2012, Job Order Contract, PJOC12 was awarded to T. Simons Co., Inc. with a total composite bid factor of 0.9700.
18. On May 7, 2013 your Board was requested to authorize a public bid of Job Order Contract JOC13, with a bid date of June 13, 2013. On July 23, 2013 the Board awarded the PJOC13 contract to T. Simons Co., Inc. with a total composite bid factor of 0.9300.
19. On May 13, 2014 your Board was requested to authorize a public bid of Job Order Contracts JOC14-1 and JOC14-2, with a bid date of June 12, 2014. The Director of General Services executed the contract, with the Board's approval, for JOC14-1 to Newton Construction & Management, Inc. on June 27, 2014 with a total composite bid factor of 0.9395. The Director of General Services executed the contract, with the Board's approval, for JOC14-2 to R. Burke Corporation on July 9, 2014 with a total composite bid factor of 0.9400.
20. On May 5, 2015 your Board was requested to authorize a public bid of Job Order Contracts JOC15-1 and JOC15-2, with a bid date of June 4, 2015. The Director of General Services executed the contract, with the Board's approval, for JOC15-1 to Kinyon Construction, Inc., Inc. on June 18, 2015 with a total composite bid factor of 0.9392. The Director of General Services executed the contract, with the Board's approval, for JOC15-2 to R. Burke Corporation on June 19, 2015 with a total composite bid factor of 0.9240.
