**RESOLUTION RECOGNIZING THE JACOBS FAMILY FOR THEIR EXEMPLARY SERVICE TO THE

The following resolution is hereby offered and read:

WHEREAS, Family Care Network, Inc. (FCNI) has selected the Jacobs Family as the recipients of the 2016 “Circle of Serving” Award for their collective and individual efforts towards enhancing the wellbeing of children and families in San Luis Obispo County through years of exceptional, multifaceted community service; and
