RECOMMENDATION

We respectfully recommend that the Board of Supervisors approve the attached resolutions for County employees who have accomplished 30 or 35 years of service.

DISCUSSION

In 1966, the Board of Supervisors adopted the County's Employee Recognition Program, which included as one of its elements a Service Recognition Program honoring County Employees who have been employed by the County for five years and at additional five-year intervals. Under the adopted procedures, employees with 30 or more years of service are to be honored by presentation of their commemorative item at a Board of Supervisors' meeting. The program also includes recognition within departments and a bi-annual countywide celebration for employees who reach 20 and 25 year milestones.
