**RESOLUTION COMMENDING DAVE O'HALLORAN
UPON HIS RETIREMENT AFTER 34 YEARS OF PUBLIC SERVICE
WITH THE COUNTY OF SAN LUIS OBISPO
IN THE PUBLIC WORKS DEPARTMENT**

The following resolution is hereby offered and read:

WHEREAS, Dave O'Halloran received his degree in Civil Engineering from Cal Poly University, San Luis Obispo in June 1982; and

WHEREAS, Dave began work on July 19, 1982 as an Engineer I in the County Engineering Department assigned to the Construction Division; and

WHEREAS, Dave was assigned progressively more complex assignments which led to his receiving registration as a Professional Engineer in 1985, receiving a promotion to Engineer III in 1986 and to an Engineer IV in 1989; and

WHEREAS, Dave was promoted to an Engineer V in 1998 to become the Department of Public Works' Construction Division Manager, a position he has held for the past 18 years; and

WHEREAS, Dave has mastered the elements of field and office processing for a wide variety of construction projects; and

WHEREAS, Dave has conducted business with contractors in constructing these public works in a calm, positive, and steadfast manner while assuring the County's interest (and minimizing construction claims); and

WHEREAS, in the course of Dave's work he has provided construction management or oversight on over two dozen bridge construction projects, paving of over 300 miles of roads, repair of numerous storm damage sites, and upgrades to several utility and flood control systems throughout the County; and

WHEREAS, Dave has provided dedicated service to the County including oversight of the Willow Road Interchange project construction; and

WHEREAS, Dave in his retirement will seek to enjoy the natural resources of the County including fishing, surfing, and hiking.

NOW, THEREFORE BE IT RESOLVED AND ORDERED, that the County of San Luis Obispo, Board of Supervisors, State of California, does hereby commend Dave O'Halloran upon his retirement following thirty-four years of dedicated service to the County in the implementation of needed public infrastructure and does hereby wish him well in all his future endeavors.
