RESOLUTION CREATING NEW JOB CLASSIFICATIONS, ESTABLISHING THE ASSOCIATED SALARY, AND AMENDING THE POSITION ALLOCATION LIST

WHEREAS, Chapter 2.48, Section 160 of the San Luis Obispo County Code provides that the number of positions and the classifications of said positions allowed within each department shall be established by resolution of the Board of Supervisors; and

WHEREAS, pursuant to Section 2.48.090 of the San Luis Obispo County Code, the compensation of all officers and employees of the County of San Luis Obispo shall be regulated by resolution of the Board of Supervisors of said County;

WHEREAS, the job classification being created by this resolution has been reviewed by the Human Resources Department and is consistent with job specifications and classifications as provided by the Civil Service Commission; and

WHEREAS, the County Administrator has met with the Human Resources staff and concurs with the recommended changes.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, that the job classification and the associated salary be created as follows:
