**RESOLUTION ACCEPTING CERTAIN ROADS  
INTO THE COUNTY MAINTAINED ROAD SYSTEM  
RICHARD AVENUE, COUNTY ROAD NO. 5059  
ELLIS AVENUE, COUNTY ROAD NO. 5382  
LEONARD PLACE, COUNTY ROAD NO. 5528**

The following Resolution is hereby offered and read:

**WHEREAS**, the County of San Luis Obispo, State of California has, by policy of the County Service Area 21 Cooperative Road Program, been duly requested to accept the offers of dedication for certain roads into the County maintained road system; and

**WHEREAS**, under the Cooperative Road Improvement Program, an Assessment District entitled *Road Improvement Zone – Leonard Place of County Service Area No. 21* in the community of Cambria was approved on May 15, 2015, by majority vote on Measure A-15; and

**WHEREAS**, the construction of Leonard Place and segments of Richard Avenue and Ellis Avenue have been recently completed to current County A-1b Rural Road Standards and accepted; and

**WHEREAS**, the Deputy Director of the Public Works Department, by letter, has duly recommended that the Board of Supervisors accept Leonard Place and segments of Richard Avenue and Ellis Avenue into the County maintained road system; and

**WHEREAS**, certain offers of dedication to the public have been made on the Map of Cambria Pines Manor, Recorded in Map Book 5, Page 14; and

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED**, by the Board of Supervisors of the County of San Luis Obispo, State of California:

1. That 0.03 miles of Leonard Place, County Road No. 5528 between Ellis Avenue and Richard Avenue; and 0.02 miles of Richard Avenue, County Road No. 5059, from Ellis Avenue southerly; and 0.01 miles of Ellis Avenue, County Road No. 5382, from Richard Avenue easterly, offered for dedication as shown on the Tract Map Recorded in Book 5, Page 14 are hereby accepted into and made a part of the County Road System, to be maintained in kind, and shall and does constitute County highways in the County of San Luis Obispo.
2. That the County Clerk be and hereby is authorized and directed to record a copy of the resolution in the Office of the County Recorder of the County of San Luis Obispo.

3. Said offers of dedication are by Harry E. Jones, C. Bailes, Orville Routt, Frank M. Wise, and O.L. Bishop.
