RESOLUTION ESTABLISHING CHANGES TO THE TRAFFIC REGULATION CODES FOR NO PARKING ZONE ON AVILA BEACH DRIVE AND LAUREL STREET, AVILA BEACH; E STREET, CAYUCOS; OAKGLEN AVENUE, NIPOMO; NO PARKING AND TOW AWAY ZONE; OLD COUNTY ROAD, TEMPLETON AND VISTA DEL RIO, NIPOMO; NO OVERNIGHT PARKING AND TOW AWAY ZONE ON BENNETT WAY AND LIMITED PARKING ZONE ON CROCKER STREET, TEMPLETON; DISABLED PARKING ZONE ON SECOND STREET, LOS OSOS; AND ANGLED PARKING ZONE ON THIRTEENTH STREET, SAN MIGUEL

The following resolution is now offered and read:

WHEREAS, the County of San Luis Obispo seeks to ensure a safe and efficient road network; and

WHEREAS, the locations listed on Exhibit "A" have been reviewed in the field for operations and safety; and

WHEREAS, the Department of Public Works has determined that the road locations listed on Exhibit "A" warrant the actions proposed therein; and

WHEREAS, the Board of Supervisors is authorized to adopt the traffic regulations referenced herein by resolution pursuant to sections 32, 21458, 22500, 22502, 22503, 22507, 22511.7 and 22651 of the California Vehicle Code and section 15.01 of the County Code.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, the Traffic Regulation Code for the County of San Luis Obispo is hereby amended as shown on the attached Exhibit "A" by the addition of sections contained therein.

Exhibit A

Amendments to the Traffic Regulation Code **County of San Luis Obispo**

The following sections are added to Chapter 15 of the San Luis Obispo County Traffic Regulation Code:

15.67.314 Bennett Way, Templeton

After signs are erected giving notice thereof, it is unlawful at any time from one-half hour after sunset to one-half hour before sunrise to park a motor vehicle on Bennett Way (County Road No. 5501) from Vineyard Drive (County Road No. 5156) thence south to the southerly terminus of Bennett Way for the purpose of allowing occupants thereof to camp, live or sleep within the motor vehicle. For the purpose of this section, any motor vehicle parking during the time mentioned herein and which, (1) contains a person or persons sleeping therein, or (2) contains bedding arranged for purpose of, or in such a way as will permit the occupants thereof to remain, shall be deemed a violation of this section.

15.67.315 Vista Del Rio, Nipomo

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following locations: along the northwesterly and southeasterly sides of Vista Del Rio (County Road No. 1532) from the centerline of Hutton Road (Count Road No. 1514) southwesterly one thousand one hundred and twenty feet.

15.67.316 Old County Road, Templeton

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the northwesterly side of Old County Road (County Road No. 5185) from the centerline of Florence Street (County Road No. 5179) thence northeast to the centerline of Eddy Street (County Road No. 5189).

15.72.304 Thirteenth Street, San Miguel

Angled parking is created and established along the southerly side of Thirteenth Street (County Road No. 6029) from the centerline of Mission Street (County Road No. 6016) to the centerline of the San Miguel Alley (County Road No. 6020).

15.400.111 Laurel Street, Avila Beach

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the easterly side of Laurel Street (County Road No. 2079) from the southeasterly curb return with the intersection of Ocean Oaks Drive (Non-County Maintained Road) to a point forty-five feet south of the said curb return.

15.400.133 Avila Beach Drive, Avila Beach

After signs are erected giving notice thereof, no person shall park a vehicle anytime at the following location: Along the southerly side of Avila Beach Drive (County Road No. 2070) from the western curb return with the intersection of San Miguel Street (County Road No. 2081) to a point one-hundred and twenty feet west of the said curb return.

15.400.653 Oakglen Avenue at Darby Lane, Nipomo

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the easterly side of Oakglen Avenue (County Road No. 1036) from a point three hundred and twenty-five feet north of the centerline of Darby Lane (County Road No. 1230) to a point two hundred and seventy-five feet south of said centerline.

15.400.654 E Street, Cayucos

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the northwesterly side of E Street (County Road No. 4272) from a point twenty feet northeast of the centerline with Bakersfield Avenue (County Road No. 4281) to a point four hundred and fifty feet northeast of said centerline.

15.402.601 Second Street, Los Osos

The following location is designated as a parking area for the exclusive use of disabled persons and disabled veterans displaying distinguishing license plates and placards: Along the easterly side of Second Street (County Road No. 3212) from a point three hundred and twenty-five feet south of the centerline of Santa Maria Avenue (County Road No. 3128) to a point three hundred and fifty feet south of said centerline.

15.404.222 Crocker Street, Templeton

After signs are erected giving notice thereof, no person shall park a vehicle for a greater length of time than thirty minutes between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday, along the northwesterly side of Crocker Street (County Road No. 5191) from the northern curb return of the intersection with Fifth Street (County Road No. 5197) to a point fifty feet north.

The following sections are deleted from Chapter 15 of the San Luis Obispo County Traffic Regulation Code:

15.400.117 Old County Road

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the northwesterly side of Old County Road (County Road No. 5185) from the centerline of Florence Street (County Road No. 5179) thence northeast to the centerline of Eddy Street (County Road No. 5189).

15.400.643 Vista Del Rio, Nipomo

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: along the northwesterly and southeasterly sides of Vista Del Rio (County Road No. 1532) from the centerline of Hutton Road (County Road No. 1514) southwesterly one thousand one hundred and twenty feet.
