SUBJECT: Request to approve the agreement with Access Support Network in the amount of \$55,000 for preventive health grant funds from Fund Center 106 – Contributions to Other Agencies. All Districts.

RECOMMENDATION

It is recommended that the Board approve the agreement with Access Support Network in the amount of \$55,000 from Fund Center 106 – Contributions to Other Agencies grant funds.

DISCUSSION

During the Fiscal Year 2016-17 Budget Hearings, the Board approved grant funding for a variety of organizations in Fund Center 106 – Contribution to Other Agencies. Access Support Network (ASN) was approved for grant funding in the amount of \$55,000 from the Preventative Health Grant category. The funds will be used by ASN in support of their Housing Assistance Program, the Hepatitis C Project and the Needle Exchange Program.

OTHER AGENCY INVOLVEMENT/IMPACT

Various non-profit organizations are included in the list of grant recipients. County Counsel has reviewed and signed the agreements.

FINANCIAL CONSIDERATIONS

During the budget process, the Board approved a total of \$1.4 million in grant funding for the Fund Center's various grant programs (district community projects, community based organizations, preventive health and other agencies grants). Access Support Network was approved for a \$55,000 grant.

RESULTS

This financial support will assist non-profit agencies in providing essential services to County residents that are not provided by the County or provide a service that contributes to the health, economic, and social well-being of County residents. Each organization is required to provide a scope of work with the details relating to meaningful measurable results. Specifically, as noted above, the funds will be used by ASN in support of their Housing Assistance Program, the Hepatitis C Project and the Needle Exchange Program. FY 2015-16 results can be found attached to this report.
