**RESOLUTION PROCLAIMING THE TERMINATION OF LOCAL  
EMERGENCY RELATED TO THE 2016 CHIMNEY FIRE**

The following resolution is offered and read:

**WHEREAS**, a Proclamation of Local Emergency for the entire County of San Luis Obispo was made by the Director of Emergency Services on August 20, 2016, due to the effects of the Chimney Fire; and

**WHEREAS**, pursuant to County Code section 2.80.070(1), the Board of Supervisors ratified the Proclamation of Local Emergency on August 23, 2016; and

**WHEREAS**, County Code section 2.80.070(2) requires that the Board of Supervisors review, at least every thirty days until such local emergency is terminated, the need for continuing the local emergency and proclaim the termination of such local emergency at the earliest possible date that conditions warrant; and

**WHEREAS**, on September 13, 2016, the Board of Supervisors reviewed the need to extend and continue the Proclamation of Local Emergency, concluding that conditions still existed warranting extending and continuing the Proclamation of Local Emergency; and

**WHEREAS**, the reasons for making the Proclamation of Local Emergency, which included the need to facilitate a streamlined process to immediately utilize all necessary

resources to mitigate the effects of the Chimney Fire, to call upon mutual aid via the assistance of other counties and agencies, and to issue orders and regulations necessary for the protection of life and property, no longer exist because the Chimney Fire has been contained and is no longer a threat to public health and safety;

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED**, by the San Luis Obispo County Board of Supervisors that the Proclamation of Local Emergency for San Luis Obispo County related to the 2016 Chimney Fire shall terminate at 11:59 P.M. on October 4, 2016.


