RESOLUTION ACCEPTING CERTAIN OFFERS OF DEDICATION FOR SANITARY SEWER PURPOSES

The following Resolution is hereby offered and read:

WHEREAS, there is a public need for the County of San Luis Obispo, State of California to accept portions of certain offers of dedication necessary for the construction, installation, operation, maintenance and repair of a wastewater collection and treatment system; and

WHEREAS, the Director of Public Works has duly recommended that the Board of Supervisors accept the following offers of dedication for the public road purpose of constructing, installing, operating, maintaining and repairing wastewater collection and treatment facilities:

1. The sixty foot wide offer of dedication as described in Volume 1736, Page 967 of Official Records offered by Gerald W. Noble; and
2. The offer of dedication as described in Volume 1799, Page 462 of Official Records offered by Margaret J. McQuown

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, by the Board of Supervisors of the County of San Luis Obispo, State of California that:

1. The following offers of dedication are hereby accepted for the public road purpose of construction, installation, operation, maintenance and repair of a wastewater collection and treatment system, and are hereby accepted for and on behalf of the public and shall and do constitute easements for sanitary sewer purposes in the County of San Luis Obispo:
 - (a) The sixty foot wide offer of dedication as described in Volume 1736, Page 967 of Official Records offered by Gerald W. Noble; and
 - (b) The offer of dedication as described in Volume 1799, Page 462 of Official Records offered by Margaret J. McQuown.
2. Said offers of dedication described herein are not being accepted as county roads and shall not constitute part of the County maintained road system.
3. That the County Clerk be and hereby is authorized and directed to record a copy of the Resolution in the Office of the County Recorder of the County of San Luis Obispo.
