### RESOLUTION ESTABLISHING NO PARKING AND LIMITED PARKING ZONES

The following Resolution is now offered and read:

**WHEREAS**, the County of San Luis Obispo seeks to ensure a safe and efficient road network; and

**WHEREAS**, the locations listed on Exhibit A have been reviewed in the field for operations and safety; and

**WHEREAS**, the Department of Public Works has determined that the roads listed on Exhibit A warrant control of on street parking; and

**WHEREAS**, the Board of Supervisors is authorized to adopt the traffic regulations referenced herein by resolution pursuant to sections 32, 22502, 22507, and 22507.5 of the California Vehicle Code and section 15.01.040 of the County Code; and

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** by the Board of Supervisors of the County of San Luis Obispo, State of California, that Chapter 15.67 and 15.400 of the Traffic Regulations Code for the County of San Luis Obispo is hereby amended as shown on the attached Exhibit A by the addition of sections contained therein to said Chapter.

**EXHIBIT A**

**Amendments to the Traffic Regulation Code  
County of San Luis Obispo**

**Establishment of No Parking, and Limited Parking**

- I. That Chapter 15.400 of Title 15 of the San Luis Obispo County Traffic Regulation Code is hereby amended by adding the following sections:

**15.400.630 Main Street, Cambria**

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location:

Along the southerly side of Main Street (County Road No. 5145) from a point six hundred twenty feet west of the centerline with Santa Rosa Creek Road (County Road No. 5086) to a point six hundred fifty feet west of said centerline.

**15.400.631 Florence Street, Templeton**

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location:

Along the westerly side of Florence Street (County Road No. 5179) from the centerline with Salinas Avenue (County Road No. 5176) to a point eighty five feet north of said centerline.

**15.400.632 Buckley Road, San Luis Obispo Fringe**

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location:

Along the southwesterly side of Buckley Road (County Road No. 2089) from a point two thousand nine hundred fifty feet northwest of the centerline with State Highway 227 to a point three thousand fifty feet northwest of said centerline.

- II. That Chapter 15.404 of Title 15 of the San Luis Obispo County Traffic Regulation Code is hereby amended by adding the following sections:

**15.404.211 Tefft Street, Nipomo**

After signs are erected giving notice thereof, no person shall park a vehicle for a greater length of time than ten minutes at the following location:

Along the southeast side of Tefft Street (County Road No. 1018) from a point two hundred feet southwest of the centerline of Oakglen Avenue (County Road No. 1036) to a point two hundred forty feet southwest of said centerline.

15.404.212 South Ocean Avenue, Cayucos

After signs are erected giving notice thereof, no person shall park a vehicle for a greater length of time than thirty minutes at the following location:

Along the northeast side of North Ocean Avenue (County Road No. 4256) from a point one hundred twenty five feet northwest of the centerline of D Street (County Road No. 4273) to a point one hundred thirty-five feet northwest of said centerline.

15.404.213 South Ocean Boulevard, Cayucos

After signs are erected giving notice thereof, no person shall park a vehicle for a greater length of time than thirty minutes at the following location:

Along the southwest side of North Ocean Avenue (County Road No. 4256) from a point one hundred thirty-seven feet southeast of the centerline of Cayucos Drive (County Road No. 4287) to a point one hundred forty-seven feet southeast of said centerline.

15.404.214 Cayucos Drive, Cayucos

After signs are erected giving notice thereof, no person shall park a vehicle for a greater length of time than thirty minutes at the following location:

Along the northwest side of Cayucos Drive (County Road No. 4287) from a point sixteen feet northeast of the centerline of Ocean Front (County Road No. 4403) to a point twenty-six feet northeast of said centerline.

15.404.215 Encina Avenue, Santa Margarita

After signs are erected giving notice thereof, no person shall park a vehicle for a greater length of time than two hours at the following location:

Along the southwest side of Encina Avenue (County Road No. 3109) from a point thirty-nine feet northwest of the centerline of State Highway 58 to a point one hundred eighty-five feet northwest of said centerline.
