# Management and Oversight

- Increased collaboration and management oversight
- Better integration of jail medical and mental health services
- Continuing to add resources
  - 17 FTE and \$2.3M since FY 2011-12



# In-Jail Policy and Procedure Changes

- Many operational changes
- Updated policy for emergency administration of medication
- Inmates found incompetent to stand trial transferred within days
- Welfare and Institution Code 5150 holds written as medically indicated



# Changes Made Outside the Jail

- Psychiatric Health Facility (PHF), limited capacity
- Inmates occupying increased share of beds
- Purchase of bed days in other facilities, outside of County



# Moving Forward

- Implement any FBI recommendations
- Assessment of jail medical
  - Spoken to several vendors
  - Could be completed in 60-90 days
  - Costs vary widely based on depth of review requested



# Moving Forward

- Outsourcing of jail medical
  - Identified 4 vendors in California
  - Most California counties outsource some portion (medical, juveniles, mental health)
  - May include vendor assessment as part of contract
  - Cost is driven by services requested
  - Implementation often 60-90 from contract sign
  - Cost estimated \$2.5M-\$4.2M/year
