RESOLUTION DECLARING MARCH 10-18, 2012 AS “NATIONAL AMERICORPS WEEK”  
AND HONORING THE CAL POLY VOLUNTEER INFRASTRUCTURE PROJECT  
AMERICORPS PROGRAM**

The following resolution is hereby offered and read:

**WHEREAS**, AmeriCorps was created in 1993 under the Clinton Administration, through the National and Community Service Trust Act, to create a nationwide corps of citizens dedicated to national service; and

**WHEREAS**, In September 1994, the first class of AmeriCorps members—20,000 strong—began serving in more than 1,000 communities; in July 3, 2003, President Bush signed the Strengthen AmeriCorps Program Act, which nearly doubled the number of AmeriCorps members; and

**WHEREAS**, In April 2009, President Obama signed the Edward M. Kennedy Serve America Act, which reauthorized and will expand national service programs administered by the Corporation for National and Community Service including increasing the number of AmeriCorps members serving from 75,000 to 250,000 by 2017; and

**WHEREAS**, the Cal Poly Volunteer Infrastructure Project AmeriCorps Program was established as a local AmeriCorps program at the Cal Poly Community Center and enrolled its first members in August 2010; and

**WHEREAS**, the 2012 Cal Poly Volunteer Infrastructure Project AmeriCorps Program consists of 28 members working at 22 non-profit and community agencies throughout the county; and

**WHEREAS**, the Cal Poly Volunteer Infrastructure Project AmeriCorps Program has made a meaningful impact in addressing community needs, assisting non-profit and community agencies to administer high quality programs and services; and

**WHEREAS**, March 10 – 18, 2012, has been designated as National AmeriCorps Week and local corps members will recognize this event by participating in community service projects throughout the county.

**NOW, THEREFORE, BE IT RESOLVED**, that the County of San Luis Obispo, Board of Supervisors, State of California, does hereby declare March 10–18, 2012 as “National AmeriCorps Week” in San Luis Obispo County and honors the Cal Poly Volunteer Infrastructure Project AmeriCorps Program.
