SUBJECT: Request to approve an agreement with HomeShare SLO allocating a total of \$6,000 from Districts 1 and 2 Community Project Funds - Fund Center 106 to be used for expenses associated with the outreach and training events given to county residents. Districts 1, 2.

### **RECOMMENDATION**

It is recommended that the Board approve the agreement allocating \$6,000 from Districts 1 and 2 Community Project Funds – Fund Center 106 to HomeShare SLO.

### **DISCUSSION**

HomeShare SLO's mission is to change lives and connect people and homes by matching home providers with home seekers. In order to place County residents in housing, the program must conduct outreach and trainings so residents understand program benefits, are able to interact and socialize with other potential program clients, and staff are able to determine who may be eligible and appropriate to participate.

The \$6,000 in County funds will be used towards expenses related to outreach and training events, and intake/screening services for clients, distributed between all 5 supervisorial districts.

### **OTHER AGENCY INVOLVEMENT/IMPACT**

HomeShare SLO is an organization that supports affordable housing and supportive services for home seekers.

### **FINANCIAL CONSIDERATIONS**

Funding in the amount of \$6,000 will be allocated from Districts 1 and 2 Community Project Funds – Fund Center 106 to HomeShare SLO.

## **RESULTS**

The funds will be used to provide 36 outreach and training events for San Luis Obispo county residents, during October 2018 – September 2019.
