SUBJECT: Submittal of a resolution establishing the 2017-18 Special Tax Rate and confirming the per parcel special tax amount in County Service Area No. 21, Bradford Road Improvement Zone, Cambria. District 2.

RECOMMENDATION

It is recommended that the Board:

1. Approve the resolution confirming the 2017-18 County Service Area No. 21, Bradford Road Improvement Zone special tax rate of \$2,390.30 per parcel having a separate County Assessor's Parcel Number and increasing not more than two percent per year thereafter.
2. Direct the Clerk to file the approved copy of the Resolution with the County Auditor no later than August 10, 2017.

DISCUSSION

On September 21, 2010, the electorate in County Service Area No. 21, Bradford Road Improvement Zone voted for approval of a special tax to repay the General Fund loan that funded the paving of a section of Bradford Road. Fiscal Year 2017-18 will be the sixth year that the tax will be levied, which will continue until the loan is paid in full; the current rate will be \$2,390.30 per parcel.

In order to levy the tax during the 2017-18 fiscal year, the Board must pass a Resolution establishing the 2017-18 rates, and confirming the amount of the special tax levied on each parcel of real property. The special tax is authorized per Section 25215.2 of the Government Code.

OTHER AGENCY INVOLVEMENT/IMPACT

County Counsel has reviewed the subject Resolution and approved it as to legal form and effect. The Offices of the Auditor-Controller and Treasurer/Tax Collector are involved in the process of collecting special taxes on the property tax bills. The County Clerk will file the resolution with the Auditor-Controller.

FINANCIAL CONSIDERATIONS

The recommended action will generate approximately \$16,700 in revenue, which will fund the annual loan debt payment to the General Fund. The loan funded the paving of a section of Bradford Road.

RESULTS

This action will provide sufficient funds to repay the loan from the General Fund. The funds being paid back were originally used to pave a section of Bradford Road in Cambria. This has enhanced the quality of life for those participating in the project, and contributed to a safe and prosperous community.
