SUBJECT: Request to approve an agreement with South County Visitor Services as fiscal agent for Nipomo Titans AYSO Soccer Team allocating \$2,000 from District Four Community Project Funds - Fund Center #106 to be used for the expenses associated with participating in the Western States Tournament on March 25, 2017. District 4.

RECOMMENDATION

It is recommended that the Board of Supervisors approve the allocation of \$2,000 from District Four Community Project Funds - Fund Center #106 to South County Visitor Services as fiscal agent for Nipomo Titans AYSO Soccer Team.

DISCUSSION

The South County Visitor Services was formed to promote the South County communities through tourism and business development. The organization sponsors various activities that promote education, tourism, business development, and youth programs. The organization is acting as fiscal agent for the Nipomo Titans girls' soccer team. The team, made up of 9 and 10 year-old girls, won multiple area tournaments to become the number one All-Star team who will be representing California at the Western States Tournament in Carson City Nevada on March 25, 2017. Teams from California, Nevada, Oregon and Washington will be participating in the tournament.

The \$2,000 in County funds will be used for expenses for those team members to participate in the tournament who otherwise would be unable to for financial reasons.

OTHER AGENCY INVOLVEMENT/IMPACT

South County Visitor Services will act as fiscal agent for the Nipomo Titans AYSO Soccer Team.

FINANCIAL CONSIDERATIONS

Funding in the amount of \$2,000 will be allocated from Community Project Funds – Fund Center #106 to South County Visitor Services on behalf of the Nipomo Titans AYSO Soccer Team.

RESULTS

Funds will be used for expenses for those team members to participate in the tournament who otherwise would be unable to for financial reasons.
