### **RECOMMENDATION**

It is recommended that the Board adopt the attached resolution commending and thanking Creed Bruce upon his retirement from the County of San Luis Obispo after 23 years of service to the residents of the county.

### **DISCUSSION**

Creed Bruce began his career with the County on August 22, 1994 with the Department of Social Services. On September 14, 1998, he became a Cadastral Technician with the Assessor's Office. He worked with the Assessor's Office until October 3, 1999 when he became an Assistant Capital Projects Coordinator with the Technical Services Division of the County General Services Agency. Over the years, the Department has grown, expanded and been modified to where the Architectural Services group is currently a part of the County Department of Public Works – Design Division.

Creed's ability to deliver projects with grace, compassion, integrity and humor has generated confidence with staff in multiple County Departments, and resulted in an ability to manage expectations while working within the scope, schedule and budget. In recognition of his efforts, Creed was named the General Services Agency Employee of the Year for 2005.

Creed has been a dedicated public servant and has provided exemplary service to the County on numerous successful projects including:

- Remodel of the Old Courthouse;
- Projects within several County Libraries, including:
  - Atascadero
  - Cambria (2014) – Extensive remodel which received both the Harry H. Mellon and CA Counties Architects and Engineers Association awards
  - Morro Bay (2015) – Extensive remodel
  - San Luis Obispo (2017) - Extensive remodel
- Remodel of the Santa Margarita Booster Station Modular Building
- County Government Direction Kiosks – Installation which received a City of San Luis Obispo Beautification Award

Creed has long been an advocate for making sure that a project is completed safely, correctly and of the highest quality. He enjoys a good working relationship with numerous County employees because of his dedication and commitment to serve the residents of the County of San Luis Obispo. In his retirement, Creed looks forward to travelling, spending time with family and enjoying lower levels of stress.
