SUBJECT: Request to approve the appointment of Ginger Cochran as a consumer representative to the San Luis Obispo County Health Commission. All Districts.

RECOMMENDATION

It is recommended that the Board approve the appointment of Ginger Cochran as a consumer representative to the San Luis Obispo County Health Commission. Ginger Cochran will fill the vacancy left by David Clous. The term will expire July 1, 2022.

DISCUSSION

The San Luis Obispo County Health Commission was formed by the Board of Supervisors in 1994 to serve as an advisory board to the County Board of Supervisors and the County Public Health Department on matters related to health in the county. The membership of the commission consists of six (6) health care consumers who are not direct or indirect providers of health care; two (2) indirect providers of health care, defined as those individuals who are affiliated with the health care system and who are providing support services; and three (3) direct providers of health care services. The term of each member seat is for four years.

There is currently one consumer vacancy on the commission. The Health Commission Nominating Committee recently interviewed candidates and recommended Ginger Cochran to fill the consumer vacancy left by David Clous upon his resignation on June 11, 2018. This vacancy has been posted by the County Clerk Recorder's Office.

Ginger has a background as a Registered Dietitian Nutritionist and Certified Diabetes Educator. Ginger will provide an excellent perspective in representing consumers of health services.
