SUBJECT: Request to declare the results of the August 27, 2019, Templeton Community Services District Special Election. Districts 1.

RECOMMENDATION

It is recommended that the Board declare the results of the August 27, 2019, Templeton Community Services District Special Election.

DISCUSSION

A special election was conducted by all mail ballot in the Templeton Community Services District on August 27, 2019, for the election of a levy of a special tax on real property located within the district to provide 24-hours a day, 7 days a week staffed fire and emergency services.

All vote-by-mail have been counted and the official canvass has been completed. The County Clerk has certified the election and signed the Certificates of County Clerk and is submitting this to your Board along with the Summary Reports of Final Official Election Results and the Statements of Votes Cast. Pursuant to Elections Code §15400, the governing body shall declare the results for each measure voted upon under its jurisdiction at the election as well as declare elected or nominated to each office, the person having the highest number of votes for that office.

OTHER AGENCY INVOLVEMENT/IMPACT

Templeton Community Services District staff and County Counsel worked with the Elections Division of the County Clerk-Recorder's Office to conduct this election.

FINANCIAL CONSIDERATIONS

The County Clerk-Recorder's Office will be reimbursed by the Templeton Community Services District for all expenses in conducting the election. The estimated cost of conducting the election is \$30,000.

RESULTS

To have the Board of Supervisors declare the results of the votes cast at the August 27, 2019, Special Election held in the Templeton Community Services District as prescribed by law.
