SUBJECT: Request to approve an agreement with the Jewish Community Center Federation of San Luis Obispo allocating a total of \$2,000 from District Three Community Project Funds - Fund Center #106 to be used for expenses associated with three free family-friendly film screenings on dates in January 2020. District 3.

RECOMMENDATION

It is recommended that the Board of Supervisors approve the agreement allocating a total of \$2,000 from District Three Community Project Funds – Fund Center 106 to the Jewish Community Federation of San Luis Obispo by 4/5 vote.

DISCUSSION

The Jewish Community Federation of San Luis Obispo, a non-profit organization works to connect and educate the community through programs and services that promote cultural awareness on the Central Coast. The San Luis Obispo Jewish Film Festival is a cultural gem attracting over 600 Central Coast residents each year. The festival includes eight film screenings and two receptions. In addition, the festival hosts three free community screenings for nearly 300 county residents, ranging from ages 4 – 104.

The \$2,000 in County funds will be used towards the free community screenings which will target residents of all backgrounds to promote cultural awareness on the Central Coast, specifically educating on the American Jewish experience and issues related to anti-Semitism.

OTHER AGENCY INVOLVEMENT/IMPACT

The Jewish Community Federation of San Luis Obispo will coordinate the this event.

FINANCIAL CONSIDERATIONS

Funding in the total amount of \$2,000 will be allocated from District Three's Community Project Funds – FC 106 to the Jewish Community Federation of San Luis Obispo.

RESULTS

The funds will be used for promoting and holding the events noted above. The events encourage community and family participation and promote cultural awareness on the Central Coast.
